STRATEGIC INSIGHT

The first strategic planning session for the NASCEE Board allowed the Board members to revisit, refine and reconnect to the NASCEE vision and mission.

Although the Board members each represent different interests and offer different value propositions in their organisations, they were able to find common ground and develop a mutual framework of trust.

The key consideration for the session was finding a balance for NASCEE between what needs to be done and what could reasonably be done with the resources available to NASCEE. In other words, creating a sustainable programme of development by considering



both our *governance responsibilities* and improving the *sustainability of our initiatives*.

Governance includes addressing the responsibilities NASCEE has to its members, and the level of delivery and interaction NASCEE needs to adopt to address important issues, make the necessary impact, and keep members engaged.

Sustainability involves understanding what resources NASCEE has available, the financial requirements of its programme of action, how it will be raising funds, and building the NASCEE membership base.

The Board reiterated that **NASCEE is defined by its membership** - who we are able to reach, who we represent and who we can involve in our programme of action. This makes the membership considerations the cornerstone on which NASCEE needs to build its strategies, tactics and actions.

Board members renewed their commitment to the perspectives and inputs provided by the keynote speakers at the 2019 NASCEE Conference. The NASCEE vision, mission and purpose statements were refined to:

Vision


We see a future where non-profit organisations (NPOs) in education are recognised and valued by all stakeholders for making a meaningful contribution to quality education for all in South Africa.

Mission

It is our mission to empower NPOs in education by improving their visibility, capacity, effectiveness and commitment to collaboration in order to magnify their impact and influence.

Purpose

We work to maximise the collective contribution of NPOs towards achieving transformational systemic education through the fulfilment of the national targets set out in the National Development Plan as well as the global targets set out in the United Nations' Sustainable Development Goals (SDGs).

In the meantime, the Board has decided to expand NASCEE's influence to all three levels of shaping the education system (macro, meso and micro) and to build a strong membership base. Closer towards the 2020 NASCEE conference we will launch our first working groups.

POTENTIAL ALLIANCES

In an effort to build a network to strengthen its resilience and influence, the NASCEE Board has met with representatives from IPASA and SAMEA. It is hoped that we will be able to support each other in our mutual efforts to improve South African education, learning from one another as we work towards shared goals.

The **Independent Philanthropy Association of South Africa (IPASA)** is a voluntary association with 30 members, mostly family foundations based in South Africa. The association has been in existence for four years.

IPASA values its independence from government and the corporate sector. The association networks with philanthropists so that they can learn from one another. By supporting the learning cycle and enabling thought leadership, IPASA helps philanthropists to make a meaningful impact and facilitate change for the better in South Africa. As such, it respects and honours the principle of equity, and transformation and diversity are key criteria in their decisions about what work to support.

IPASA invests time and energy into on-boarding new members to ensure commitment and alignment with the practice of the association. Members have adopted a code of conduct that guide their collaborative projects.

The association concentrates on improving the quality of the projects they fund and improving the support provided to these projects.

IPASA holds four formal meetings and a two-day symposium every year. In addition, it actively engages its members in projects and markets its initiatives to raise additional funds.

The **South African Monitoring and Evaluation Association (SAMEA)** was founded in 2005 to cultivate a community that supports, guides and strengthens the development of monitoring and evaluation as an important discipline and profession and instrument for empowerment and accountability in South Africa.

SAMEA has members in every province as well as regional chapters. It offers resources, capacity building and forums for members to engage with monitoring and evaluation themes. In addition, the association organises a biennial conference.

SAMEA maintains a WhatsApp group and a webinar for members, plus a web café, held on a quarterly basis. Three provinces use mainly face-to-face communication because of their rural nature but email is the preferred and main communication channel for members.

A technical working group is in place which reviews articles and technical issues for communication with members via the website.

SAMEA currently has 600–650 members in any one year, with an increase of membership in conference years. In addition, there are eleven institutional members.

BUILDING A PLATFORM

Rand Merchant Bank joined our planning session to present their work on the Edvision Platform. Their presentation highlighted that the platform’s focus is to map organisations, including NGOs/NPOs and donors, who are involved in education, to list who they are, what they do, where they do it and who funds their work. Presently, it is extremely difficult to identify all the organisations that are operating in the various provinces because of varying levels of communication and disclosure.

Edvision is an online platform, the initial development of which is being funded by Rand Merchant Bank. The goal of the platform is to reduce market inefficiency through, firstly, landscaping who is doing what in education and where they are doing it and, secondly, fostering meaningful connections between players in education.

The following points were noted:


- Edvision is about transparent engagement, coordination and collaboration.
- Edvision is a potential partner for NASCEE; NASCEE could assist and guide individuals and NGOs/NPOs to use the platform.
- Although research and M&E papers, etc. are not included on the platform yet, these could be in the next few years.
- In time, the platform could be used to indicate areas where government is focusing its work.

The board considered that the Edvision platform could enable NASCEE to play an active part in a dynamic education ecosystem that is interoperable, white labeled, open-source and supported by artificial intelligence.

There is a compelling argument for considering the Edvision platform and a continued partnership as a defining opportunity for NASCEE.

Sharing information and enabling supply-demand matching through a ledger driven service for learning and development would revolutionise getting projects off the ground.

At this stage it is clear that the opportunity needs to be investigated further. A working committee from the NASCEE Board is working with Rand Merchant Bank to launch in early 2020.



COMING UP

The NASCEE Board is hard at work exploring partnerships, fundraising and establishing the proper governance processes for NASCEE.

The NASCEE Team is working on starting 2020 off with an action packed agenda. These include:



A community radio campaign

We are working on making contact with community radio stations to discuss the six education priorities identified by government representatives at the 2019 NASCEE Conference. The intent is to promote NASCEE and some of the work its members are doing around the themes: early childhood development, vocational education in schools, the fourth industrial revolution, professional development in the education sector, STEM education, and reading and early literacy. Our target launch date for this is January 2020.



A series of webinars and podcasts

In an effort to create flexible content that can be shared, discussed and developed into a critical resource library, the team is starting to work on material for webinars and podcasts. Much of the work will focus on helping NASCEE members stay current and develop forward-looking, practice-based communities. To be launched just before or at the NASCEE 2020 Conference.



Regional champions and chapters

As we register our members and work on the priority issues, the NASCEE Team will, together with the Board, identify and appoint regional champions. The champions will spearhead the establishment of regional chapters, working groups and other theme driven interactions.
